# Why have a Community Safety and Crime Prevention Plan?

The City of Gosnells is committed to helping make the community a safe and inclusive place for everyone.

Safety is an important priority for the City of Gosnells, its residents and community members, ranking as the second Strategic Priority in the City's Strategic Community Plan 2023 – 2033.

Local government is well placed to lead and support local community safety initiatives and to facilitate partnerships with key stakeholders to help achieve a community where people feel safe and able to fully participate in community life.

The Community Safety and Crime Prevention Plan 2025 – 2030 has been developed to address key community safety concerns which have been identified through community consultation, stakeholder engagement and crime statistics from the WA Police Force.

The Plan identifies the actions of the City and key partners over the next three years to improve community safety within the City of Gosnells.



### Crime and Safety in the City of Gosnells

The City of Gosnells spans the Armadale and Cannington Police Districts, including Gosnells, Canning Vale, and Cannington Police Stations. Crime statistics, available on the WA Police Force website, show a slight overall decrease in crime across all suburbs despite population growth. This trend indicates that places and spaces are becoming safer across the City of Gosnells.

However, crime hotspots and spikes still occur due to targeted criminal activity or changing circumstances. The City is committed to working with the Police and key stakeholders to help resolve issues.


#### Consultation Methods

The City undertook an extensive stakeholder and community consultation process to identify the priority areas for the Community Safey and Crime Prevention Plan 2025 – 2030. This included:

- Reviewing the feedback received from the community about community safety during the 2023 Strategic Community Plan consultation.
- Online surveys and quick polls on the City's engagement platform Your Say Gosnells.
- Promotion of the survey and quick polls through various City communication channels including:
  - Website
  - Social Media
  - eNewsletters
  - Posters at various community facilities.
- ▶ Drop-in sessions and on-site surveys at various City facilities.
- Regular meetings with the Officers in Charge of the Gosnells, Canning Vale and Cannington Police Stations.


#### Consultation Results

The community was asked how safe they felt overall in the City of Gosnells:




The community was asked how safe they felt in their street:

The community was asked how safe they felt in town centres in the City of Gosnells:




### Key Community Safety Concerns

The top perceived community safety issues were:

- ▶ Burglary 23.83%
- ► Stealing 16.82%
- ► Assault 10.28%
- Disorderly conduct 9.35%

### Community Priority Areas

Four priority areas emerged from the feedback received from the community consultation:

- ▶ 1. Safe Homes: protecting residents' homes and property.
- 2. Safe Spaces: addressing areas where residents feel unsafe.
- **3. Early Intervention:** implementing programs for early engagement with youth and addressing emerging crime problems.
- 4. Strong Partnerships: Collaborating with various agencies and stakeholders to address crime and improve safety.
