

# LOCAL GOVERNMENT ACT 1995

## City of Gosnells

### CITY OF GOSNELLS AMENDMENT LOCAL LAW 2025

Under the powers conferred by the *Local Government Act 1995*, and under all other powers enabling it, the Council of the City of Gosnells resolved on [Date] to make the following local law.

#### PART 1—PRELIMINARY

##### 1.1 Title

This local law is the *City of Gosnells Amendment Local Law 2025*.

##### 1.2 Commencement

This local law comes into operation 14 days after the date of its publication in the *Government Gazette*.

##### 1.3 Application

This local law applies throughout the district.

##### 1.4 Local Laws amended

This local law amends the *City of Gosnells Public Health Local Law 2017*, the *City of Gosnells Fencing Local Law 2017*, the *City of Gosnells Dogs Local Law 2020*, and the *City of Gosnells Parking Local Law 2012*.

#### PART 2—CITY OF GOSNELLS PUBLIC HEALTH LOCAL LAW 2017

##### 2.1 *City of Gosnells Public Health Local Law 2017* amended

This part of the local law amends the *City of Gosnells Public Health Local Law 2017*.

##### 2.2 Clause 8.3(3) amended

Clause 8.3(3) is amended by deleting “\$5,000” and replacing it with “\$10,000”.

##### 2.3 SCHEDULE 1 – PRESCRIBED OFFENCES amended

SCHEDULE 1 – PRESCRIBED OFFENCES is amended as follows—

- (1) In Item 34 of the table, delete the modified penalty value of “500” and replace it with “1,000”.

- (2) In Item 35 of the table, delete the modified penalty value of “500” and replace it with “1,000”.
- (3) In Item 36 of the table, delete the modified penalty value of “250” and replace it with “1,000”.
- (4) In Item 39 of the table, delete the modified penalty value of “250” and replace it with “1000”.

### **PART 3—CITY OF GOSNELLS FENCING LOCAL LAW 2017**

#### **3.1 *City of Gosnells Fencing Local Law 2017* amended**

This part of the local law amends the *City of Gosnells Fencing Local Law 2017*.

#### **3.2 **Clause 5.1** amended**

Clause 5.1 is amended as follows—

- (1) Delete “\$250” and replace it with “\$500”.
- (2) Delete “\$5,000” and replace it with “\$10,000”.

### **PART 4—CITY OF GOSNELLS DOGS LOCAL LAW 2020**

#### **4.1 *City of Gosnells Dogs Local Law 2020* amended**

This part of the local law amends the *City of Gosnells Dogs Local Law 2020*.

#### **4.2 **Schedule 3 – OFFENCES IN RESPECT OF WHICH MODIFIED PENALTY APPLIES** amended**

Schedule 3 – OFFENCES IN RESPECT OF WHICH MODIFIED PENALTY APPLIES is amended as follows—

- (1) In Item 1 of the table, delete the modified penalty value of “150” and replace it with “200”.
- (2) In Item 2 of the table, delete the modified penalty value of “100” and replace it with “200”.

### **PART 5—CITY OF GOSNELLS PARKING LOCAL LAW 2012**

#### **5.1 *City of Gosnells Parking Local Law 2012* amended**

This part of the local law amends the *City of Gosnells Parking Local Law 2012*.

#### **5.2 **Clause 1.4** amended**

Clause 1.4 is amended by inserting the following definitions in alphabetical order—

“***electric personal transporter*** has the meaning given to it in the Code;

***electric rideable device*** has the meaning given to it in the Code;

***electric vehicle*** means a vehicle that—

- (a) is powered by an electric motor or motors; and
- (b) can be recharged from an external source of electricity,

but does not include an electric personal transporter or electric rideable device;

**electric vehicle charging bay** means a parking bay designated by a sign for the use of electric vehicles, with an external source of electricity available for charging an electric vehicle stopped or parked at that bay;”

**5.3 New clause 7.7 added**

After clause 7.6, add a new clause 7.7 as follows—

**“7.7 Parking in electric vehicle charging bays**

- (1) A driver must not stop or park a vehicle in an electric vehicle charging bay unless the vehicle is—
  - (a) an electric vehicle; and
  - (b) connected to the external source of electricity available for that electric vehicle charging bay for the purpose of charging the vehicle.
- (2) Unless otherwise signed, a person may not park in a designated electric vehicle charging bay for longer than 2 continuous hours.”

**5.4 Clause 9.1(2) amended**

Clause 9.1(2) is amended by deleting “\$5,000” and replacing it with “\$10,000”.

**5.5 Schedule 1 – Prescribed offences amended**

In Schedule 1 – Prescribed offences, insert the following rows in the table after CLAUSE 7.6—

7.7(1)(a)	Stopping or parking a vehicle other than an electric vehicle in an electric vehicle charging bay	100
7.7(1)(b)	Stopping or parking an electric vehicle in an electric vehicle charging bay when the vehicle is not connected to the external source of electricity for that bay	100
7.7(2)	Stopping or parking for longer than 2 hours in an electric vehicle charging bay	100
